Standard Operating Procedure

1. Purpose

The Shotfiring Committee is a standing committee covering the aims of the Federation in area of promotion of standardization and harmonization of explosives training in Europe and in promotion of explosives technology in all fields related this technology. The Council establishes standing committees. The committee members appoint a Chairman that reports regularly to the Board. The Committee reports to the Board on daily matters. The aim of the Federation is to create a course, according to the valid European Shot firer Requirements, for a standardized assessment of technical competencies for the shot firer / blast designer profession in European Union. The final target in this area is to enable this category of professional engineers to apply for jobs outside their own countries without time-consuming delays in obtaining appropriate permits. EFEE, through its members, has access to research results, papers presented at national conferences and methods utilized by the industry throughout the Europe. It is an EFEE member obligation in Committee to bring new information in area of explosives technology in all fields related to this technology.

3. Deliverables

- The materials with examining questions, exercises, the course based on these materials and the online courses, which will be available on the internet for free on www.shotfirer.eu.
- Guidebook based on the learning material for trainers and shot firers who want to learn independently online.

4. Responsibilities

Chairman of Shotfiring Committee is responsible for:

- 1. Preparation of standard requirements for the training of specialties like rock blasting, demolition and others.
- 2. Participation in relevant discussion on the topic, the distribution of papers and the general information on training.
